<u>Driving Events Committee</u> seeks representatives

Nominations are open for regional representatives to the national **Driving Events Committee** (DEC.)

The BMW CCA DEC supports driving events conducted by chapters, and national events such as Oktoberfest. The driving-events program is intended to promote driver education and safety by providing a framework for members to improve their driving skills in a fun, safe environment. The Driving Events Committee is responsible for planning and overseeing the BMW CCA Driving Events Program. The Committee —Updates, maintains, and enforce sthe driving school, autocross, and other minimum standards published in the BMW CCA Operations Manual.

- —Monitors the driving-school standards. In the event of a chapter violation, the elected DEC representative for that region will work with chapter representatives to arrive at an amicable solution that meets the standards. If the regional representative and the DEC as a whole cannot effect a solution, the matter will be referred to the National Board for resolution.
- —Facilitates and oversees the National Driving School Instructor Training (ITS) programs.
- —Assists chapters in creating or improving their driving-events

programs. The Driving Events Committee consists of one representative from each region, to be elected by chapter representatives in each region. Additional members may be appointed by the National Board.

Nominations must be received at the National Office no later than Monday, November 15, 2010, 5:00 p.m. Eastern time. Both the nominator and the nominee must be BMW CCA members who reside in the region for which the nomination is being made. The form may be used to submit nomination(s) may be submitted by letter, but must include the name, address, BMW CCA member number, and signature of the nominator; and the name, address, and BMW CCA member number of the nominee. Nominees may include a 300-word candidacy statement that will be included with the ballots for their region. Before their names are placed on the ballot, nominees will be contacted to confirm their willingness to serve. After all nominations have been received and confirmed, the National Office will prepare a ballot to be mailed to the driving-events coordinator (or equivalent position) of each chapter. Each chapter's driving-events coordinator may cast one vote for the representative for their region. If a chapter does not have a driving-events coordinator, chief instructor, or equivalent position, that chapter's vote may be cast by the chapter president.

Nominators and nominees should understand the process, eligibility, and responsibilities of DEC members, and consider these qualifications carefully prior to the nomination.

Membership numbers still falling slightly. September membership was 65,550, down from August's 61,824 total. The club got 1,160 renewals and mailed out 63,060 Roundel magazines monthly.



BMW X3 M-Sport at Paris Show

BMW's stand at the Paris auto show will feature a brand-new M Sport package for the new 2011 X3, which is making its debut.

As seen in these preliminary photos, the X3's M treatment will include new, lower front and rear bumpers; deeper side skirts; and different wheels.

Other M Sport packages come with adaptive suspension, so that could be in the cards.

Also expect minor interior changes like a new steering wheel and M sill plates.

The second generation X3 has

more-cohesive styling that's complemented by the M Sport package. Though the new X3 is larger, the use of aluminum has kept weight comparable with the outgoing model.

The base xDrive28i model has a 240-hp, 3-liter, 6-cylinder engine, while the xDrive35i is powered by a 300-hp turbocharged 3-liter. BMW forecasts 0-60 mph in 6.7 seconds for the base car, 5.5 seconds for the xDrive35i. An eight-speed automatic will be the only transmission and the latest xDrive all-wheel drive will be standard. —Paul Duchene



2010 BMW CCA membership drive

Last year CCA Members participating in our annual membership drive brought over 900 new members into the Club. Let's do better this year.

To get credit for signing up a member, make sure the person adds your name and member ID to any paper form or online form.

<u>BMW CCA Membership Contest</u> rules

These are the official rules and as such supersede any description listed elsewhere and any verbal Feb. 18, 2010 to Dec. 16, 2010 The BMW CCA membership drive is open to three categories of participants:

Current BMW CCA members, Current BMW CCA members who work for a BMW dealer or independent BMW shop, and BMW CCA chapters. New Membership Definition: A new membership is defined as a membership for an individual who has not previously belonged to BMW CCA, or an individual who was previously a BMW CCA member but whose membership lapsed at least six months prior to the date of the new membership. A new membership with a corresponding associate membership counts as one new membership.

Eligibility: To be eligible, current BMW CCA members must be paid members in good standing through December 31, 2010 (that is, they may not be members by virtue of being "comped" by BMW CCA or a BMW CCA chapter). Categories: The program differentiates between BMW CCA members who work at BMW dealers or independent shops and those who don't. The reason for this is because those who work at places where BMWs are sold, serviced, or repaired are assumed to have a much greater opportunity to meet BMW owners who may not already be members of BMW CCA. While all BMW CCA members have equal opportunities to receive a reward for the new member, they will only be competing against other members in their own category for the grand prizes.

Category 1: Rewards for current BMW CCA members who refer new members. For each new member that joins, referring members will receive \$5.00 in "BMW CCA Bucks" that can be used for the purchase of any goods sold by BMW CCA or applied to CCA memberships. There is no limit to the amount of "BMW CCA Bucks" a member may receive based on new member referrals. "BMW CCA Bucks" expire one year from the date of issue and have no cash surrender value. Additionally, there will be grand prizes for the 3 BMW members

who refer the most members. "BMW CCA Bucks" will be applied as a credit in the membership record of the awardee.

"BMW CCA Bucks" may be used to purchase BMW CCA merchandise or they may be applied toward the renewal of a BMW CCA BMW CCA Bucks expire one year from date of accrual and have no cash surrender value. Date of accrual is Dec. 17, 2010.

Category 2: Rewards for BMW dealer or independent BMW shop employees who refer new members Current BMW CCA Members employed by a BMW dealer or independent BMW shop: For each new member that joins, referring members will receive \$5.00 in "BMW CCA Bucks" that can be used for the purchase of anything sold by BMW CCA. There is no limit to the amount of "BMW CCA Bucks" a member may receive based on new member referrals. Additionally, there will be grand prizes for the 3 BMW members in this category who berships. refer the most members.

"BMW CCA Bucks" will be applied as a credit in the membership record of the awardee.

".Please note that memberships purchased by dealers for their customers are not eligible. This exclusion is in effect even if a current BMW CCA member is listed on the application as a referrer.

Category 3: Rewards for chapters that achieve a designated level of new member activity.

Chapters are eligible for rewards based on an overall increase in their total membership and their renewal rate. Both are important for continued growth of the Club, since renewing members are more likely to stay in the Club for more years, while new members are needed to replace those members who don't renew. Only primary chapter memberships will count toward chapter goals. Secondary chapter affiliations will not accrue towards the goals. To be eligible for rewards, chapters must be in

good standing. Chapters that are officially on probation during the period of the membership drive will not be eligible. The basis for chapter goals for new members will be the total number of primary members as of the official close in the National Office on February 18, 2010. The goals for chapters that gain or lose members due to chapter realignment or the creation or dissolution of chapters will be revised so that they maintain an equitable basis for rewards.

The total membership goal for each chapter is 15 percent; that is, the chapter will have reached its goal if, by Dec. 16, 2010, its total number of primary members is equal to 115 percent of the number of primary members assigned to the chapter as of Feb. 18, 2010.

The renewal goal for each chapter is 90 percent; that is, the Chapter will have reached its goal if, by Dec. 17, 2010, at least 90 percent of its primary members as of Feb. 18, 2010 have renewed their memberships.

Chapters that meet either their total membership goal or their renewal goal, but not both, will receive \$100.00 of "BMW CCA Bucks" or \$5.00 of "BMW CCA Bucks" per 100 members, whichever is greater.

Chapters that meet both their total membership and renewal goals will receive \$150.00 of "BMW CCA Bucks" or \$15.00 of "BMW CCA Bucks" per 100 members, whichever is greater.

Chapters that meet their renewal goal and meet or exceed 110 percent of their total membership goal will receive \$200.00 of "BMW CCA Bucks" or \$20.00 of "BMW CCA Bucks" per 100 members, whichever is greater, and a 5 percent discount on driving event insurance premiums for the year 2011.

Chapters that meet their renewal goal and meet or exceed 120 percent of their total membership goal will receive \$300 of "BMW CCA Bucks" or \$30.00 of "BMW CCA Bucks" per 100 members, whichever is greater, and a 10 percent

discount on driving event insurance premiums for the year 2011.

The top ten chapters in percentage of new members and renewal rates will be officially recognized in Roundel Magazine.

New members can join: By calling 1-800-878-9292 to submit their application and credit card information over the telephone. The referring member's name and BMW CCA member number must be provided at the time the call is made.

web site and submitting an appli**cation online.** To receive credit, the referring member's name and BMW CCA member number must be entered in the appropriate space on the online application form. By mailing a membership application to the National Office. In order to receive credit, the referring member's name and BMW CCA member number must be written on the application. Membership applications/BMW CCA brochures are available from the National Office by calling (864) 250-0022 or sending an e-mail to stevens@bmwcca.org.

Deadline, Procedures and Restrictions: In order to be counted, the National Office must receive all new member applications no later than Dec. 16, 2010.

If referred by a current BMW CCA member, a new member application must contain the name and BMW CCA member number of the referring member in order for the referring member to receive credit. Credit may not be applied retroactively. If a new member cancels their membership within three months after joining, the referring individual will lose credit for that membership.

If a new member is referred by a current associate member, the associate member will receive the "BMW CCA Bucks." BMW CCA Bucks" will be awarded at the end of the program only to those who are members in good standing at that time.

A Desert Win for Festorics

I thought some of you would enjoy an update on the little Florida colored BMW 1600-2 that tried so hard to get in and out of Death Valley on our club drive last November.

Prior to our restoration the car sat in the front yard of a house in Jean, Nevada for over a decade. It required so much attention that the restoration has taken us several years to complete.

In addition to the new paint, polished trim, and completely restored interior, it took a great deal of time to locate a lot of the rare early style components to fully rebuild the engine, transmission and the oil filled axles.

Thanks to a lot of dedicated effort from members Patrick Barnett and Rob Vey, we were finally able to complete the long awaited restoration.

The vehicle was just sold on eBay and is currently heading back to New York, but prior to the sale we were invited to display the car at the Festorics in Monterey - an event not to be missed.

In fact, I don't think you can even call yourself an enthusiast of early BMW's if you have NOT been to the Festorics! Jeff Cowan and a team of volunteers from the Golden Gate Chapter hosted a perfect event.

It began on the Friday with the "Legends of the Autobahn" which is the West Coast Summer Concours held on a beautiful golf course in Carmel Valley where a stunning collection of BMW, Mercedes, and Porsche models are all on display for your viewing pleasure.



After winning a lovely trophy, we enjoyed a fabulous banquet dinner and a host of entertaining speakers, including presentations by Steve Dinan and racing legend Scott Pruett. For the following two days our 1600-2 had been selected by Jeff to be on display in the BMW hospitality tent in Turn Five at Laguna Seca. It turns out that our desert rescue project held a very unique history for the model (Special thanks to Satch Carlson for taking the time to confirm this with Manfred Grunert while in Munich).

As most of you know, Max Hoffman was the man responsible for bringing BMW to the United States, and is often credited with helping create, launch, and ensure the overwhelming success of the BMW 1600 and 2002 models that has lasted to this day.

To start his new BMW import line, Max ordered a pair of 1600-2's, however for reasons that remain unclear, these two cars shipped to

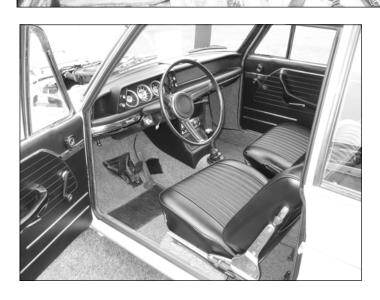

Hoffman were immediately returned. Finally on October 20, 1966 he received his first order, a pair of BMW 1600-2's, and as we recently discovered our little 1600-2, VIN 1506913, was part of that pair, making it one of two of the very first 1600's to be delivered to the Hoffman Motor Company.

Perhaps Max drove this one daily, or perhaps it was the one in the show-



room that helped create our first obsession with BMW's newest sport sedan. Either way, it makes for a great feeling knowing that an old BMW rescued from the Las Vegas desert was one of the actual 1600's that started it all for Max Hoffman...

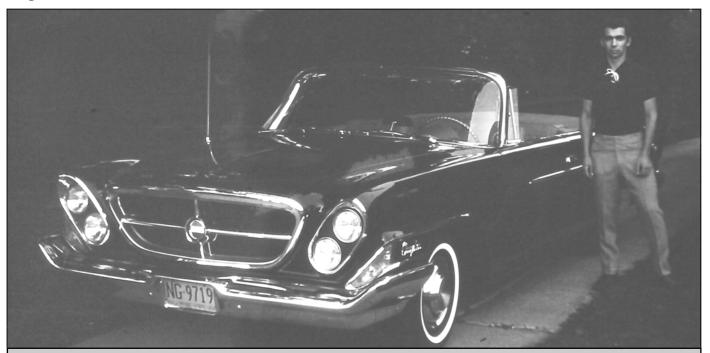
