BMW CCA BOARD MEETING OCTOBER 27-28, 2007 Greenville, South Carolina

MINUTES

Saturday, October 27, 2007

1. Call to Order:

The meeting was called to order at 8:04 am.

2. Attendees:

3. Minutes:

The minutes of the June 30-July1, 2007 Board meeting were approved by vote of the Board on August 15, 2007 via e-mail. Reading of the minutes was dispensed with.

4. Reports:

4.1. Presidents Report:

Scott Blazey had nothing to add to his pre-meeting report.

4.2. Vice President:

Mark Jon Calabrese reported that the Foundation has requested to be included in the Roundel as an affiliated organization. There was no objection.

4.3. Secretary:

Bruce Hazard had nothing to add to his pre-meeting report.

4.4. Treasurer.

Louis Goldsman had nothing to add to his pre-meeting report.

4.5. Pacific RVP:

Steve Johnson had nothing to add to his pre-meeting report

4.6. South Central RVP:

Fred lacino had nothing to add to his pre-meeting report.

4.7. North Central RVP:

Len Mueller had nothing to add to his pre-meeting report.

4.8. South Atlantic RVP:

Paul Dunlevy had nothing to add to his pre-meeting report.

4.12. Driving Events Committee:

Bill Wade had nothing to add to his pre-meeting report.

4.13. Roundel:

Satch Carlson had nothing to add to the Roundel pre-meeting report.

4.14. bmwcca.org:

Bill Howard provided an update on the website.

5. Discussion Topics:

5.1. National Programs and Services:

- 5.1.1 *Club Racing*:
 - Mike Mills requested a change in the name of the Club Racing Advisory Committee to Racers Advisory Committee. There was no objection.
 - Mike Mills requested a one-time exception to policy of the two-year term of the North Atlantic RAC Representative, so that the North Atlantic RAC representative's term is synchronized with that of the North Atlantic Regional Vice President.

MOTION: Len Mueller made a motion for a one-time change to the term for the North Atlantic RAC representative to one year, so as to correspond with the term of the North Atlantic RVP. Louis Goldsman seconded the motion. IN FAVOR: ALL

- MOTION: Louis Goldsman made a motion to appoint Mike Mills as Club Racing Chairman for 2008. Fred lacino seconded the motion. IN FAVOR: ALL
- Mike Mills raised for discussion the purpose and appropriateness of the Canadian RAC representative. The history is that early in the Club Racing program, the Chairman believed that Canadian racers should be represented since club races were being held in Canada and the program had a number of Canadian racers. As a result, the position of Canadian representative was created, but it was made a non-voting position on the committee. Mike Mills did not request any further action at this time.
- Mike Mills reported that there was a potential CR sponsor that provides gift cards and wanted to connect CR and BMW CCA members in the card benefits. The Board has also had inquiries from several other affinity cards in addition to the current affinity card program with Bank of America. Since this is not time sensitive, the Board decided to table this and have the new Executive Director evaluate all the options and make a recommendation.

5.1.2 Driving Events Committee:

 Bill Wade reported that some Chapters were not conducting driving events in accordance with the minimum standards. Sometimes this was because the organizers were not aware of or familiar with the standards.

- There was a discussion of how best to publish the various minimum standards so that new event organizers were aware of the standards and veteran organizers were reminded. It was decided that to save the Chapter volunteers the time of poring through the entire Operations Manual, we would create a handy extract of all the minimum standards and post it on all the Chapter officer digests, for the RVP's to send as reminders, and to provide in the Chapter Officer Tool Box section of the website.
- It was pointed out that CR and other committees are required to meet annually but not the DEC.

MOTION: Steve Johnson made a motion to include in the Operations Manual a requirement for the DEC committee to meet annually. Len Mueller seconded the motion. IN FAVOR: ALL

- Bill Wade observed that the event insurance renews in January 2008 and he is fielding requests from insurance companies. Bill will evaluate coverage's and confer with Pete Lyon on acceptable alternatives.
- Bill observed that many driving schools are seeing aggressive driving by instructors and this could be a potential problem. The chapters will be reminded that aggressive driving must be recognized as a potential safety issue.

5.2. Executive Director Search:

- 1. Scott Blazey reported that the executive search firm Tryon & Heideman, has received 84 applications, sent follow-up questions to selected candidates, conducted telephone interviews, will be conducting face-to-face interviews and then selecting a short list of candidates to be interviewed by the Search Committee (Scott Blazey, Bruce Hazard and Paul Dunlevy) in Kansas City on November 27-29.
- 2. A final candidate or two will be selected to be interviewed by the full Board at the January Board meeting.
- 3. Scott, Louis Goldsman, Len, and Wynne met with the National Office staff to review the interim operations plan. The detailed plan is in the Executive Directors pre-meeting report which is attached.

5.3. National Events:

5.3.1 **Oktoberfest 2007:**

- Linda Axelson provided an after action report which is attached to these minutes.
- Linda also provided her top ten lessons learned and a brief update of the financials.

5.3.2 **Oktoberfest 2008:**

 Linda's attached report outlines details and a proposed schedule for the shortened four-day event with driving schools each day.

5.3.3 Oktoberfest 2009 and Beyond:

- Linda's report outlined future venues.
- At the next Board meeting Linda will provide a first look at a five-year planning schedule for future Oktoberfests.

 The Badger Bimmer Chapter has expressed interest in Oktoberfest 2010 with the driving school at Road America near Elkhart Lake.

5.3.4 Newsletter Editor/Webmaster Conference:

• The conference will be held at the Sheraton City Center in Salt Lake City, Utah, April 4-6, 2008.

5.3.5 Sponsor, Vendor, Advertiser Relations:

- Scott Blazey suggested that when something happens that causes a disagreement or friction with a long-time vendor, advertiser, or sponsor, that extra ordinary efforts should be taken to see if the relationship can be repaired. He suggested that before any such relationship is allowed to be severed, the President make a personal effort to contact the company and determine if there is a way to maintain the relationship.
- The Board agreed.

5.4. Financial

- 5.4.1 **2007 P&L:**
 - Louis Goldsman reported that the year-end position is projected to be close to the budget.

5.4.2 Affinity Card Programs;

- Scott reported that the Board has received inquiries from BMW Financial and PartnersFirst for a credit card affinity program.
- It was agreed that any future affinity agreement must:
 - not infringe on current affinity program(s), at least through the expiration of such agreements
 - provide at least the current revenue the Club receives (approx. \$40,000 annually),
 - o provide tangible benefits to the members,
 - o provide benefit to the provider

5.5. Chapter Issues:

- 1. There were no Chapters on probation.
- 2. Wynne reported that the Chapter Officer Toolbox is completed and waiting to be linked to the website.
- 3. As indicated in his pre-meeting report, Scott Blazev proposed a change to the mandatory requirement that Chapters mail a hard copy of their newsletter to designated individuals outside the Chapter (currently the National Office, Board members, and National Service Officers) and the voluntary mailing of hard copies to all other chapters, BMW CCA provides a rebate to chapters of their postage and printing costs for these hard copies. The proposal was to establish on the bmwcca.org web site an easy way for chapters to upload electronic copies of their newsletters. receive immediate credit for meeting the newsletter minimum standard, and automatically generate to National Board members, Service Officers, staff, and other chapters that would be available for viewing on line. This would eliminate the additional printing and postage of over 100 copies of each issue of each newsletter generated by each chapter (well over 30,000 newsletters annually, saving time, money, and resources. The logical file type would be PDF, since it is almost universal, many chapters already post PDF's of their newsletters to their own web sites, and most page layout and word processing programs already contain the capability

to easily generate PDF's. For those chapters that do not have the capability, the Club could provide training and assistance. The logical kickoff and explanation of the details of such a policy would be the 2008 Newsletter Editor/Webmaster Conference.

The Board liked the proposal. Bill Howard will develop and test it before the Newsletter Editor/Webmaster Conference in April 2008.

4. The IMIS program that National uses is getting old and upgrades are difficult, it is recommended that the new Executive Director review it's functionality and consider upgrade or replacement after 6 months.

5.6. BMWCCA.org

- Bill Howard reviewed his pre-meeting report in greater detail.
- The new website should be delivered about November 10 and there will be 2-5 days of files copying and validating. Go-live is anticipated November 15th

5.7. *Membership:*

5.7.1 **Online renewal limitations**:

Due to limitations of iMIS (membership data base) early renewal (prior to three months from expiration) is not possible. The same is true of renewals for Associate members, which must be done at the time of the full member. This should be corrected so that members can renew anytime. If this is not possible with iMis, then this becomes a significant factor in determining if iMis should be retained as our database.

5.7.2 Membership Drive

The membership drive for 2008 is in planning and prizes are being solicited, with a kickoff target of January 1, 2008.

5.7.3 Marketing Plan

BMWCCA.org is the first step which is due to be launched the middle of November. Following this the printed materials will be redone.

5.7.4 BMW CCA Presence at Non-CCA events

- Steven Schlossman raised the idea of having a presence at non-CCA events such as the various fest's and tuner shows. The goal would be to gain members and develop interaction with the sponsoring organizations.
- There was unanimous support. Questions raised included which events, whether to enlist local chapter volunteers to assist, how to measure success, and what would it cost in relation to benefit.
- Linda Axelson will do some research on cost.
- The first realistic possibility would be Bimmerfest on May 3, 2008 in Santa Barbara, CA.

5.8. Administration:

5.8.1 Operation Manual Change

 Attached is the final draft of language to be added to the Operations Manual and the National Office's Employee Handbook regarding discussion of sensitive topics and the appropriate procedure for escalating an issue that an employee or contractor feels needs to be brought to the attention of the Board. MOTION: Len Mueller made a motion to approve the draft language. Paul Dunlevy seconded the motion. IN FAVOR: ALL

5.8.2 Continuity of Operations

- During the interim period until a new Executive Director, the following motions were made regarding financial transactions.
- MOTION: Louis Goldsman made a motion to appoint Linda Axelson and Tricia Jones as authorized check signers and that any check over \$50,000 will require two signatures. Steve Johnson seconded the motion. IN FAVOR: ALL
- MOTION: Steve Johnson made a motion to authorize Louis Goldsman the authority to close and open accounts if necessary in order to manage CD's and other financial accounts. Fred Iacino seconded the motion. IN FAVOR: ALL

5.9. Regional Events

There were no requests for Regional status.

5.10. International Council of BMW Clubs

- The minutes of the recent meeting held in Salzburg, Austria are attached.
- Mark Jon Calabrese represented BMW CCA and he reported on new standards for the use of the BMW roundel logo and its impact on our national and chapter logos. The current designs and guidelines are 25 years old and there is still inconsistency in how they are implemented.
- The current plan is for approval in 2008 and implementation in 2010, but there are many issues and concerns.

5.11. Bylaws:

As a follow-up to the discussion at the last Board meeting Bruce Hazard reported on the results of the survey of members regarding national elections and term limits.

- 5.11.1 The survey was conducted in two parts. The first consisted of general questions about the election process and interest in running for national office. There were 1720 responses from the 9,810 members were invited to participate. The results:
 - Less than 17% have ever volunteered at the chapter or national level.
 - For those that did, their motivation: 48% just wanted to contribute, 2.6% had a specific issue(s) they wanted to affect.
 - Of the ones that decided not to run: 5.3% either knew the incumbent and or didn't want to run against the incumbent, 25% didn't think they could win on the National level. The remaining 68% had various reasons: the largest group was didn't want to, didn't have time or was a new member; there was a rather significant group that didn't know what was involved, not familiar with National business, don't know the responsibilities, etc.
 - As for recommended changes: most didn't see a need for changes, they weren't interested in active campaigning and thought that the 300 word essay was sufficient. However, there were scattered votes for the opposite. Electronic voting is very popular. There was one suggestion for term limits and one that thought that National office was a clique.

- 5.11.2 Len Mueller's detailed summary of the second part of the survey is attached to these minutes. There were 803 responses from the 9,054 members were invited to participate. In summary the survey showed:
 - 90% felt that the Board should actively recruit future Board members.
 - 65% felt that all positions on the Board should be term limited. (Currently only the President is term limited.) The reasons included: want new blood, fresh outlook/ideas/faces, opportunity, decrease power of incumbency, a variety of leadership/styles, simple change, get rid of status quo and "good old boys", perceived *Roundel* inner circle, etc.
 - 85%+ suggested 6 year terms and 60%+ suggested 4 year terms.
 - As for the 35% that didn't feel terms limits were necessary: If the person is doing a good job then leave them; it is too difficult to find candidates to run or volunteer; institutional memory, experience and continuity are important.
 - Most of the 700 respondents felt that members don't run for national office because of a perception that things are run by a small group of insiders.
- 5.11.3 There was a vigorous discussion:
 - Most felt that, as was identified in the first survey that a better effort is needed to educate potential volunteers on the duties of each position and realistically what it takes to do the job well. There was no single conclusion as to how to accomplish this except that the website could be one tool.
 - There was also general agreement that a better job could be done in proactively recruiting volunteers to run for positions and reduce the number of uncontested races.
- 5.11.4 As for term limits there were many arguments for and against:
 - Arguments For:
 - It was the preference of 65% of the survey respondents.
 - If there is a perception the Board members stay too long, then term limits may address this perception.
 - How can it hurt if term limits are implemented that match or are longer than the historical average terms lengths for an individual position.
 - Arguments Against:
 - In recent years there have been very few Board members that stayed in one position of more than 6 years; therefore, term limits aren't likely to change anything.
 - It is unlikely that the perception will change just by setting term limits that approximate the historical average terms lengths for an individual position.
 - Changes to the By-Laws should not be made easily or frequently and should be reserved for issues that are substantial, not in the hope of changing perceptions.
 - If an effort is made to educate the membership of the responsibilities and expectations of Board members along with actively recruiting volunteers to run for contested positions, this would likely do more to change the negative perception identified in the survey.

 Other than in the survey there has not been a much discussion, suggestion or comments from members regarding term limits. Therefore, is the survey an indication of real dissatisfaction or just feelings on term limits in general?

8. Discussion Topics:

8.1. Bylaws (continued):

- 8.1.1 The discussion on term limits continued and Scott Blazey asked the Board to consider if:
 - Incumbency, especially with long-serving Board members, is an unfair advantage that discourages members from running for national office;
 - Term limits might result in more members bringing fresh ideas and energy to the Board;
 - The length of Board member service and perception of the Board as a hard to join insider's club is not a problem requiring a bylaws change and could be addressed in other ways.

In the following discussion, individual Board members espoused each of these positions.

8.1.2 MOTION: Len Mueller made a motion to propose a Bylaws change to the membership to be included on the 2008 national election ballot to add the following language after the first sentence in Article 6, Section 2 of the BMW CCA Bylaws that "All officers with the exception of the President, may serve not more than three consecutive two year terms in a specific office; the three consecutive term limit to begin in 2012." Louis Goldsman seconded the motion.

IN FAVOR: Len Mueller, Louis Goldsman, Paul Dunlevy, and Steve Johnson. AGAINST: Bruce Hazard, Mark Jon Calabrese, John Sullivan, and Fred Iacino. ABSTAINED: Scott Blazey.

The motion, needing a yes vote of 3/4 of the Board members present, did not pass.

8.2. New Business

8.2.1 Mark Jon Calabrese mentioned that Robin Sparrow, who runs a car in the One Lap of America event, inquired whether BMW CCA would be interested in providing support to his team with the proceeds going to a prostrate cancer charity. The consensus of the Board was:

- Many BMW's in this and other events have a charity, so if we support one then others may expect support as well.
- Most direct BMW CCA involvement with charities happens through the Chapters.
- Roundel columnists are free to raise awareness of charities and group and individual efforts using their columns.
- The website is probably the best place to run such stories as news articles and can include links to the BMW CCA members' supported charities.

Thanks – To Board Members Stepping Up

I would like to thank Mark Jon Calabrese for performing on short notice as the BMW CCA Delegate to the International Council of BMW Clubs annual meeting in Salzburg and Munich in September. When I was unable to leave home, Mark assumed the responsibility and represented the Club well.

I would also like to thank Mark Jon Calabrese, Bruce Hazard, and Fred Iacino for taking on the hosting responsibilities before and after my necessarily brief trip to Oktoberfest 2007.

Chapter Newsletter Web Posting and Printing/Postage Rebates

I have provided Bill Howard a concept for consideration that, if approved and implemented, will provide for a new, easier, and cheaper way for chapters to provide newsletters to the 106 addressees other than chapter members. (Board members, National Service Officers, BMW NA liaisons, National Office, etc.) If we have a system whereby chapter newsletter editors can log on to bmwcca.org, upload each issue of their newsletter, get confirmation of receipt, and then the system posts it to the appropriate page and sends a notification e-mail to the aforementioned 106 people, then we can save the total cost of printing and postage rebates we now pay to chapters, the chapters get instant credit for meeting the minimum standard, the 106 can view and/or download the newsletter at their convenience, and we save a lot of paper. I have prepared a mock up web site that Board members can view ahead of the meeting at http://www.scottblazey.com/Newsletters-1/Chapter_Newsletters/All%20Chapters.html

We will discuss this during the meeting. If we deem this worthwhile, and it is achievable within the constraints of our web site program, we should proceed with an eye toward having the concept, if not a date for implementation, ready for the 2008 Newsletter Editor/Webmaster Conference.

Operations Manual Sensitive Topics Discussion

It appears from your e-mails that the final draft of the policy on submitting topics for sensitive discussion is satisfactory. The topic is on the agenda for final action. A copy of the final draft is attached for your pre-meeting reference.

Credit Card Affiliation and Reward Options

During Oktoberfest we had an exploratory meeting at the request of Tom Stepanchak, General Manager, Marketing for BMW Financial Services, regarding the possibility of working with BMW CCA on a credit card option for our members that would provide continued income to the Club as well as substantial benefits to our members. We also received an e-mail inquiry from a Club member who has a private company that is also interested in a credit card relationship. Although the Board does not usually get involved with negotiating or contracting details of operational financial matters, this may be an opportunity to discuss policy to provide direction for the Club management when researching this matter, or to determine that our current situation is satisfactory.

As of today, I have not received anything from anyone running for any of the offices except a .jpeg from J.R. Schneider with a subject line of 'candidacy photo'. I am construing that to mean he's running for an office.

Follows a sampling of email I received from some who didn't want to answer the survey, or were unable to connect, but still wanted to be heard:

Hi Wynne,

For some reason, I can't link up to the specific survey website. Oh, well! For better or worse, here's my input. Maybe you can add it to the data. Basically, I'm OK with term limits for all national BOD members, but with some qualifications.

1) I'm for contiguous term limitations; i.e., limit successive terms, but

against prohibiting former BOD members from running again at some future date. A rule specifying a time gap between an officer's last term(s) and the next time s/he decides to run could be written into the bylaws.

My rationale: Experience is a valuable commodity, especially in running as big and complex a show as this club. If the term limitation clause is left open-ended - i.e., adopted without the 'run again' proviso – someone could raise questions, based on an interpretation of the clause that it in effect does not permit previous incumbents to ever run again. (A clause in Murphy's Law says 'Politics Will Raise Its Ugly Head'!) I realize that the more 'mature' incumbents may want to rest on their laurels after their last terms; but as we get younger people on the BOD, they may want to try again at a later date.

2) There should be proviso for dealing with the possibility that no one wants to run for the position left open by a departing incumbent. It sounds unlikely, but it could happen. We have such a provision, allowing the nominating committee to shanghai (blackmail?) an individual if no one volunteers. (I may be redundant here, if the national bylaws already include such a clause.)

Anyway, that's my two-cents' worth on the subject.

I'm off to the Bavaristi (E3 Registry) East Fest in Asheville next weekend. Should be great!

Thanks Wynne, I just completed the survey and voted FOR term limits. Have to eliminate power struggles.

I have not completed the survey. I will say this:

As a former Porsche Club Region President, it is my observation that the PCA National Board was not open to what they viewed as new thinking. The Board perpetuated itself and the air was not fresh at Board meetings. My impression of the BMWCCA is that it is not as formal, not as uptight as the PCA. But I could be wrong, because I have never attended a BMWCCA national board meeting.

Publication:

The **November** issue will be complete and at the printer by the time of the meeting. The issue will contain 152 pages plus covers, and twelve feature articles.

Advertising Revenue:

As of the September 2007 issue, ad billing is down 6.6% compared to 2006 with a 10% decrease in ad pages YTD compared to 2006 (55 pages over nine issues). The September issue is down less than three ad pages from the same month last year.

The 164-page September issue maintained a 36.7% ad-to-editorial-content ratio. Our self-imposed limit is 40% ad pages.

Editorial Calendar:

The most recent monthly update to the editorial calendar from the editor-in-chief was included with this report. The editor-in-chief should be able to supply an updated version at the board meeting once the December issue's content is firm.

Production Costs:

The 156-page October issue had a per-copy printing cost in line with expectations and past issues.

Financial:

The Roundel staff looks forward to providing input for the budget once we've received up-to-date account statements.

Club Website and Roundel:

You've all seen the on-line editor's report and I have nothing to add as we all await the update.

As always, we continue to feel *Roundel* is fulfilling its mission to inform, entertain, and provide a sense of community for our members. Your suggestions and constructive criticism are welcome and encouraged. If there are any questions, please don't hesitate to contact me.

BMW CCA.org fall 2007 report

Bill Howard, Editor-in-Chief, BMWCCA.org October 2007

The new site is weeks away. Site design, copywriting, business process rules (plain English descriptions of how the site should work) are all solid, in place, on target, and on time. The final coding necessary for launch of the redesigned BMWCCA.org website is in process. Unfortunately it's running slowly. Creating a solid technology link between the site and the club's iMIS database has been challenging, time-consuming, and subject to false leads and dead ends. We now appear to have a solution but it has held back the project by several weeks with final handoff from Sparks Grove, our design partner, to BMW CCA, circa Nov. 10. The site should be live within a week of the handoff.

Here's why a functional iMIS with real-time, 7x24, two-way, no-club-staffer-intervention access is critical: A prospective member must be able at any time to sign up and become a BMW CCA member instantly, since he or she may want to be online immediately, and able to see all parts of the site. (It mattered less when your interface with BMW happened monthly via Roundel.) That was something our database has been incapable of handling. The solution comprises an additional module for iMIS and some custom programming from ITI, our technology partner for the iMIS database. With this accomplished, we may be able to give back (not renew the lease) on a separate module used just for member renewals. More importantly, with these fixes that are not just BandAid fixes, the club may be able to defer the much greater cost of upgrading to the newest version of the software, iMIS 15. That is the recommendation of Webmaster Jeff Petzel. There will be a period of 2-4 days when the site (existing version) will be viewable but unchangeable: no new stories, no ad posts, no forum posts. That will be Nov. 10-13 based on the current schedule.

Other enhancements: We will have an electronic version of Roundel with great onscreen readability, many ways to search issues and across issues, and live links (web addresses in stories and ads can be clicked). I had been mixed about eRoundel because of the cost/benefit issue: It would be most appreciated by loyal members likely to remain members yet would net us few if any additional members. On the other hand, eRoundel (not just embedded PDFs) is one of those aha! things that when you see it unfold online, you really appreciate the new site.

We are looking into posting chapter newsletters online, which would result in postage savings as the main benefit, expose chapter newsletters to more members, and also make it easier to see at a glance which chapters are in compliance with minimum-newsletter-publication rules. Most likely these would be embedded PDFs rather than the cooler, costlier (\$6 to \$10 a page) Roundel-style emagazine pages. This would not be an at-launch rollout.

Jennifer Skatzes negotiated a relationship with Lands' End to provide provide logo'd club clothing, caps, and totes. (Chapters can have their logos on the site also.) Our site will link into the Lands' End – BMW CCA site. We will retain on BMWCCA.org a chapter store selling logos, pins, decals, grill badges, and Roundel back issues. Classified ads, the clothing store, and the BMW CCA store, will be the site's Marketplace section.

In the meantime we have been busy keeping the site full with stories, including more than a dozen stories posted during or shortly after Oktoberfest. You'll notice not just staff-generated stories and photos (Bill Howard, Mike Self, Jon Van Woerden) but also many member photo submissions. We also had

excellent member help pulling together a story and photo slideshows on the joint Connecticut Valley 02Fest / Boston Chapter Concours. During Oktoberfest, we recorded a site record for page views, more than 12,000 in one day.



Our presence at Oktoberfest helped in small ways. For instance, we were able to provide for the banquet a photo slideshow of all the photo contest entrants and winners (see left). It got a couple members to ask, Why not do that also for the concours? Fair question. We also are posting names of all winners of all events and major drawings, which satisfies the instant curiosity of many members who don't want to wait for the Oktoberfest issue of Roundel. We ran a story and photo slideshow on vendors and ran photos of every vendor's booth. Lastly, by focusing on happy people and cars in the slideshows, we're underscoring the general satisfaction with Oktoberfest

Fort Worth and some of that should rub off as people think about signing up for Oktoberfest Watkins Glen.

IN RE: Results of Term Limits Survey

1. Should National recruit more actively from its membership ranks to serve on the National Board? *90% said yes.* Quite impressive. Seems the National Board needs to look at recruitment, mentoring, and monitoring. A huge number of respondents demonstrated in their answers a serious lack of knowledge of how the Board operates, duties of the positions, pretty much anything and everything Board related. Whether passive or active, recruitment clearly needs to involve educating members as to what it is the Board does or is responsible for doing, and that the Board wants them to be involved.

2. What would cause you to become interested in running for a National or Chapter board position if you have never done so? A variety of reasons, most respondents citing why they haven't --reasons being 'perceived time and travel', lack of interest, not believing they have the skills, and again as in #1, not understanding what the positions entail.

3. Currently, the position of president of the national board is the only one that is term limited. Do you think the other positions should be term limited? 65% said YES, that's a huge majority.

4. If you answered YES to term limits for other board positions, please tell us why: a total of 480 respondents, most answered with the same comments and observations. Respondents want new blood, fresh outlook/ideas/faces, opportunity, decrease power of incumbency, a variety of leadership/style, simple change, they want to get rid of the status quo, '86' the good old boys, the perceived *Roundel* inner circle, some sense arrogance and complacency, they want chances for others to serve, keep focus, avoid corruption, entrenched ideas, energize, and much more of the same throughout. One complete answer is "Because certain people will dominate the political scene and hold office almost indefinitely. They may be good, but they get in the way of different ideas and improvement sometimes." This, and all the aforementioned phrases are in all answers in one way or another.

5. If you answered YES to question 3 --- What, if any, is the maximum time someone should be able serve continuously in one position? 499 answered this specifically, a few tossed since words and no number. Four years or less, **310.** For 5-6 years we have **124.** Those agreeing to 7 or more years, only **30** of 499. Several dozen added ideas for a break between continuous terms before being able to serve, whether in the same or different position. Here we have over 85% saying 6 years or less, with over 60% at four or less.

6. If you answered NO to term limits for other board positions, please tell us why. There are three clearly stated recurring themes as to why not. Of the 262 responses:

63 felt If/as long as someone is doing OK in their position, leave them there. All actually used that or a very similar phrase.

69 said 'no' because it is difficult to find others to run or volunteer.

64 replied 'no' because institutional memory/experience/continuity is important.


Another interesting part of these answers is that there is very little overlap. The rest of the answers are less clear in their support of these three reasons, but were still very close.

7. A recent survey had a few comments centering on people not running because of a perception that things are run by a small group of insiders. What are your thoughts on this concern? Agree or disagree, and why? 703 answers. Most agree and a few even named individuals. Some disagree, many don't care, a few think that having a group of insiders run the organization is a good idea, and a few just thought it a stupid question. Of the most serious responses, there was also some feeling that things won't change. Others added again that term limits should help this, or at least the perception that exists. Just reading them gives a clear flavor of what respondents think. Oddly enough, this answer had the most written responses of any, some several paragraphs, and some basing their answer on their own chapter experiences.

All in all I believe the Board's mandate is clear – and this will be a topic of discussion at this weekend's meeting in Greenville.
