### **Future O'Fest Model**

Jason Kazian reported ideas for a transition from our original model of Oktoberfest layout to move the event into regional models. This would be an annual event within each region. The regions would not necessarily have to host an event every year. These events would be branded as a national event. This has been talked about over the years and has never come to fruition. The current National Oktoberfest would then be held on anniversary dates i.e., 5, 10, 15 etc. years. Should our traditional Ofest sponsors continue to see value in sponsoring 5 smaller regional events per year and assuming they would want to travel to those 5 events the assumption is that they will continue to provide sponsorship dollars equivalent to what they now spend on Ofest. If that is true, then those dollars can be used to support the regional events. A structure for National support (contract oversight, financial risk management, registrations, event promotion and national sponsors) to be developed.

### 2023 O'Fest

Trisha Jones reported a decision needs to be made for a track event during the O'Fest 2023. The track in question is Thompson Motor Speedway, which is a 1.7 mile track. The cost for one day would be \$10,000 on Friday, \$1,000 for ambulance/fire safety, skid pad \$1,500/day and \$1,500-1,800 for corner workers. The consensus of the board was to reserve the track and sign a contract for a Friday HPDE and have an Autocross on another day.

# 6. Discussion Topics

### 6.1 National Events

### 6.1.1 Oktoberfest 2022

Tricia Jones reported the Palm Springs O'Fest Forever had low attendance. 311 total registrations. We had 179 for the Ultimate Getaway and 132 for the Weekend Escape. We did have a net loss for the event.

#### 6.1.2 Oktoberfest 2023

The event will be held September 27-October 1, 2023. The host hotel will be the Crowne Plaza in Warwick, Rhode Island. The North Atlantic Region will be assisting with HPDE, Autocross, Fun Rally, and Drives. The HPDE will be held on Friday, September 29, 2023 at Thompson Track. The track is 1.7-mile track.

Several members of the Connecticut Valley and Boston Chapters attended the meeting to contribute to the discussion on O'Fest '23 and to volunteer.

Bob and Sheila Morin of Connecticut Valley volunteered to create the Fun Rally and a couple of driving tours. President Paul Frickenhaus and CDI Michael Menatian both attended and expressed enthusiasm for the event. Michael in particular gave an enthusiastic endorsement of Thompson Motor Speedway road course. He had some good ideas about giving instructors new to the track an extra session with a track veteran before they instruct. CVC will run the school as long as they don't have any financial risk. We are trying to finalize a 1 day school on the Friday of O'Fest week.

Boston Chapter has tentatively volunteered to run an Autocross for O'fest. Audra Tella (Autocross Co-Chair), Eric Richards (Newsletter Editor), and Valerie Caprigno were in attendance. They will also want protection from downside loss. We discussed the idea of using the lot at the host hotel for Autocross. They will discuss it and get back to us. There was subsequent discussion with the hotel and after the board meeting adjourned we received the hotel's permission to use the lot for autocross. We should check local regulations, but the NARVP wasn't able to find any prohibitions after a Google search. Also subsequent to the session Thursday was suggested as the day for Autocross. We will work with Boston Chapter to formulate details. Other sites had also been considered, but one we visited on Sunday didn't look as good as the hotel lot. Further discussion is needed, but we have a good start to having a driver school and Autocross at O'Fest. Local enthusiasm seems high and volunteers have stepped forward.

## 6.1.3 Future of O'Fest Forever

2024 As we were unable to match dates at the host hotel with dates at Circuit of the Americas the offer on the table for September of 2024 fell through. The local chapters asked for reconsideration either allowing them to negotiate with the track and hotel or to look at other venues. Several RVPs noted that it was their impression that the Club was doing to take a pause on O'Fest 2024 due to cost and low participation. It was also their impression that for 2024, regional O'Fest-like events were to be considered and planned.

For 2025 and 2027 Ofest has been invited back to Pittsburgh with BMW as featured marque for the Pittsburgh Vintage Grand Prix.
